## Yesterday, Edie Windsor Got Her Day in Court.

Yesterday, the Supreme Court heard the case of *Windsor v. United States*. It was Edie Windsor's day in court. It was her opportunity to demand that the federal government treat her marriage the same as all other marriages.

On behalf of Windsor, the American Civil Liberties Union, the New York Civil Liberties Union and the law firm of Paul, Weiss, Rifkind, Wharton & Garrison urged the Supreme Court to overturn the Defense of Marriage Act. The law, known as DOMA, discriminates against gay and lesbian couples, and clearly violates the Equal Protection principles of the United States Constitution.

Edie Windsor and Thea Spyer had lived as a couple in New York City for 44 years. They married in Canada in 2007. Sadly, two years later, Thea passed away. Under federal tax law, a spouse who dies can leave her assets to the surviving spouse without incurring estate taxes, but DOMA requires the federal government to pretend that married gay couples are not married for purposes of all federal programs. As a consequence, Windsor was unfairly taxed on assets given to her by Spyer.

The American Civil Liberties Union has fought for equal treatment for LGBT individuals since 1936. We have fought to legalize marriage for same-sex couples; we have defended LGBT individuals against police harassment and workplace discrimination; and we have championed the right of lesbians and gay men to become foster parents and adopt children.

If the ACLU wins this case, we will not stop there. We will challenge DOMA laws in every state that has one. We pledge to fight until the Constitution's promise of equality for Edie and Thea - and all LGBT people - is kept.
